City Hall Ignores High Weed Removal Law for 2011

Story and photos by George Barich (Cotati, CA) - In plain sight throughout the town, acres of tall, dry weeds stand ready to ignite with the strike of a match alarming local residents and business owners. With summer officially over, and the Indian Summer well under way, these fire dangers get worse by the day. People are asking why is our city allowing these fire dangers and urban eyesores to embarrass the town like this? Cotati's Muni Code Sec. 8.16 on weed

abatement requires that all high weeds that have become a clear nuisance must be removed by approximately July of each year to prevent the high risk of wild grass fires, and to remove the visual blight that damages the town's image. Yet, with all the money City Hall has brought in as a result of the increase in Cotati's sales taxes passed by the voters in 2010, fire safety and visual blight continue to drop to the bottom of the city's priority list, or are simply being ignored altogether to

save money.

According to Tami Taylor, Cotati City Clerk, "That responsibility (high weed enforcement and abatement) has been transferred to the Rancho Adobe Fire District. We no longer do that..." It appears that the RAFD doesn't want the job either, and never agreed to take over the responsibility of high weed enforcement/abatement, according to the fire district's administrative clerk, Jennifer Ober. In investigating this story, the fire

chief, local fire marshal, city council members, and even Cotati City Manager Dianne Thompson refused to comment or return calls on this story. Equally outrageous and disconcerting, no one informed the public that the city transferred the responsibility of code enforcement to the RAFD, there was no public hearing on this matter, and the city council never voted on a change in a policy of such importance which is required by law.

September is National Preparedness Month. This caused me to reflect on the types of disasters that may affect our fire district and ability to serve our citizens.

Terrorist attacks can happen anywhere. There are international terrorists like Al Qaeda and domestic terrorists, political unrest, divisiveness and fervent causes may contribute to domestic terrorism. The risk from terrorist attacks in Sonoma County is relatively low, but Sonoma County is an ideal staging area for terror cells to set up a base of operations. We should be curious about situations that look abnormal to us and report them to authorities if necessary. Sonoma County and specifically Rancho Adobe Fire District is much more susceptible to natural disasters like floods, landslides, earthquakes, wild-land fires, thunderstorms and massive power outages.

Police Sergeant Dave Houts Not Coming Back by George Barich

Many of Cotati's newly hired police offers come through the front door of City Hall when they're hired, and go out the back when they're fired. That's really no different than many other towns. But in small towns like Cotati, news of cops going silently into the night, never to be seen again, can spread like wild fire sending shockwaves and rumors flying.



There is usually a lot of excitement and fanfare when Cotati hires a new police officer, and a lot of hope that Cotati gets a new cop that will keep his/her nose clean who will serve the community well for many

But the "revolving door" of the Cotati Police Department is legendary. Many come to Cotati fresh out of the police academy with low test scores because they can't get hired on in other cities. They would however often get hired on in Cotati, get experience under their belt after a year or two, then quit Cotati and move on down the road for more money or a more exciting position elsewhere.

Despite the long time careers of many Cotati police officers such as Dennis Wallach and Robert Stewart, to name just two, dozens have simply quit and moved on to greener pastures, or have simply been fired, eased out, laid off for budgetary reasons, and had very short careers in Cotati.

Rumor has been floating around for months now that Sergeant Dave Houts was placed on administrative leave for some unknown reason, and then recently got let go from the department for good. Rumors first surfaced that Houts had a job related injury and was taking a short leave of absence. Then rumor was he was being investigated internally by the department for allegations of wrongdoing of some kind.

Since facts surround the firing of a police officer are confidential information, the city cannot disclose these details surrounding the employment or disappearance of Sergeant Houst with the public. Rumor was that one of his wrists was in bad shape, according to witnesses of Dave working out at the local

The absence of Dave's familiar face around town has been met with some mixed feelings. Many police officers will admit they make many friends and acquaintances during their careers, and make some enemies along the way as well, which goes with the territory of being a cop.

Dave had told me in his many years serving as a Cotati police officer, I was the first and only city councilman who took the city manager up on her strong recommendation to go on a police ride-along.

Dave Houts was friendly, open, informative, and felt strongly about the job of keeping our community safe. He prided himself on keeping gang activity in Cotati to a bare minimum. It was a pleasure knowing him on a professional level for many years and getting a small glimpse into the hard work and dedication of this police officer.





Another Look at Planned City Park on Old Red'

In regards to the banner headline story by George Barich front page and page 3 of the September 2011 Cotati Independent:

As a five-term elected official who served over twenty years representing Cotati, I understand the need for officials to support their staff, and seek positive outcomes. Mr. Barich points out that prime commer-



cial property at, and along 7883 Old Redwood Highway, was purchased from Paul Oliva and Joel Rosenblum for \$1,475,000. This is higher than the "going rate" and the owners are probably happy to be done with negotiations. The property is part of a number of speculative parcels purchased with Orin Thiesen as part of the "Northern Gateway". Mr. Thiesen is not as expansive as he once was in creating developments such as the "Windsor Green" project. He and his partners had hoped to gentrify Cotati as had been done in Windsor, Graton, and elsewhere. It should be noted that Windsor gets the bulk of their tax revenue from the Wal-mart shopping area not the Windsor Green Development. Wal-Mart is the anchor store and project in Windsor, not Mr. Thiesen's project built around a "green" purchased by the Open Space District subsidized by voter approved sales tax revenues.

As stated, I have to believe that Mr. Oliva and Mr. Rosen are happy to be getting a fair price for their holdings, and to be free of negotiating with the Cotati City staff which is as pleasant and rewarding as interacting with a bed pan. The property owners worked in good faith with the city who holds the cards in development. Ms. Thompson negotiated in her usual warm and open fashion. Her style was made public when a former city official, then Cotati's Police Chief and now a Healdsburg City Council person, was at odds with Thompson for not following process or recommendations in using public funds.

Mr. Barich is concerned about a city park on a busy street. He is correct in his assumptions of costs and maintenance and even safety, as the City for some time shut down restrooms and services at their existing parks. Traffic flow should be a concern, as well as rumored underground tanks and haz-mat in the area. Old timers recall Union 76 shutting down a neighboring service station due to concerns about safe operations of their franchised station. The BP station on the other side of the freeway sat dormant for over a year as contaminated tanks were cleaned up. This is a reasonable concern but the big picture is not concerned with safety or retaining an auto shop which had moved and returned in the past few years. The property was sold to exchange funds for realigning the roadway to access Oliver's intended development of property on Saint Joseph's way. The "affordable housing' and park are required to qualify for that funding and to develop a roadway to assist the Oliver's project.

The Oliver's Market flagship original store is a tax generating business which the city supports. It has supported the enterprise in the past with a below market interest rate when Oliver's expanded into the TG&Y store and doubled its retail space. It now wishes to relocate and expand on property it has purchased options on. The city wants to help Oliver's out by sealing the deal with easy access, which requires a housing and park component. It is costly moving signals and roadways and Cotati has already done this foolishly through shortsighted planning on Redwood Drive. They now wish to secure some anchor stores for their dream of the Northern Gateway. This is commerce and makes sense as Cotati struggles to start using what is left of commercial space to generate some sales tax revenue. The housing and park may well be simply a "pocket park" and development, like the one behind Target in Rohnert Park. Many things are speculative, and it is easy to assume things, and ask questions. It would be nice if our elected officials and their staff could come forward and answer reasonable questions.

My concern and question is: What are the plans for filling the Oliver's spot in what was the Farmer's Market, behind the Crocker Bank? Many years ago we had banks and markets and growth. Now we have a bank, a supermarket, and little else that could be called economic development. Too many buildings are empty, and adding to this may not be prudent. Mr. Barich is correct that I fail to see how "Downtown Garage" will stay downtown, I further doubt it will be moving to the old Oliver's store site. The City has a plan and is trading a park and low cost housing to make for a low cost transition for Oliver's from their present location to their new location. This will, we hope, generate or retain sales tax dollars in Cotati. Workers may be able to use the affordable housing and park to advantage. I can only hope that the empty Oliver's building has a prospective long term lease to fill the anchor store in our largest shopping center.

For the future of Cotati we have to hope things "will work out". If we had had the opportunity to draw Nokia to the proposed office building development as offered by the developer of the stand-alone Lowes shopping mall, we'd have an empty building looming on that site as well. We have to look on the bright side and believe that economic recovery is "Right Around the Corner" as our City Council states at their meetings. Mr. Barich, you have to believe that our elected officials and their staff are doing what is best for us. Some sacrifice is needed. You can always get your car worked on where you buy your pants, watch a movie, or bowl.

healthcare townhall meeting, a townhall meeting for senatorial and gubernatorial candidates, and other special events with FreedomWorks and Graham Beckel.





High Weeds and Grasses Pose Serious Threat of Fire and Urban Blight



High weed fire dangers throughout the town are real and can't be denied. Yet, there seems to be no will by anyone in local government to do much of anything but ignore the problem and collect their paycheck. All it would take is one burning cigarette carelessly tossed out a car window and onto the ground of one of these parcels of land in blatant violation of the weed abatement ordinance to set the area ablaze.



When asked that question, Ober stated the official policy of the RAFD is that the fire district will only investigate these obvious fire hazards throughout the town upon receiving a formal citizen complaint. The fire district will then do a formal inspection and a report will follow days or weeks later depending on their workload and staffing level. After the report is reviewed by the chief, a letter is sent to the property owner demanding the weeds be removed within thirty days. If the weeds are not abated, a \$150 fine is imposed on the property owner, which is often just a fraction of the cost of cutting down these weeds on many of these large lots. So, where is the incentive for property owners to abate the tall grasses and weeds? According to resident Ken Coleman of Cotati, "This would be like a traffic cop observing a car speeding in town, running some stop signs, and not giving chase unless he/she first receives a complaint from a citizen. It's absurd".

Cotati's Weed ordinance 8.16 is clear that high weeds become a nuisance to the community at some point when they become so tall and/or so dry they will easily ignite at the mere touch of a flame. Such a situation triggers the ordinance and enforcement is manda-




tory. But the city has embarked on selective enforcement by delegating the responsibility to the fire district that requires first a citizen complaint. But none of this seems to be concerning the highly paid city employees at City Hall, city leaders, or the brave men and women of the Rancho Adobe Fire District. Both government agencies that have the responsibility of keeping us all safe from wild fires and urban blight say they simply don't have the manpower or resources to enforce the long-standing Cotati weed abatement ordinance. In addition, by ignoring the law it's like a tax holiday for those property owners who are used to spending hundreds of dollars each year mowing down their tall weeds and grasses. It's clear both agencies have their priorities upside down.

But the fire dangers are real now. In prior years, by the time July rolls around the city has already sent out notices to all properties with tall dry weeds and grasses that have been deemed a fire hazard by the Cotati Public Works Department to abate their weed problem within 30 days or face a hefty fine. If the property owner did not comply, the city would outsource the job of weed removal and send the property owner a bill for the work. If the


payment was not received reimbursing the city, the city placed a lien on the property.

The city is also losing thousands of dollars in fines that could have been collected at a time when they can't afford to let money slip through their fingers like this. Code enforcement costs money, and this is exactly what we expect government to be in the business of




doing, enforcing the law.

City Councilman Mark Landman, who retired from the Novato fire department, refused to be interviewed for this story. Chapter 8.16 of the Cotati Municipal Code clearly spells out the Cotati Weed Abatement Law and the procedures involved in abating these nuisances. Despite emails to city council members asking why the fire dangers continue to plague the city despite the law, all city council members refused comment. Cotati's got all these great laws on the books which have cost millions of dollars to enact over the years. But what good are all these laws if city leaders and city staff are too lazy to enforce them?



It's nothing less than selective enforcement for the local government agencies to turn a blind eye on these violations and act only upon a citizen's complaint. It is apparent that because of the city council's fiscal mismanagement and irresponsibility that we don't have adequate staffing to address the problem. Maybe someone will have to get hurt or a building will have to be burnt to the ground before these two government agencies begin doing their job rather than spending countless hours figuring out ways to raise their paychecks.

Are We Prepared?

Each winter we see weather related disasters causing flooding, necessitating water rescues, trees down, electrical problems and downed wires. We observe that fire resources are stretched very thin and that without the dedication of our crews who respond off duty to the stations to up staff other apparatus, we would be hard pressed to provide a high level of service.

In a serious disaster, like an earthquake, the response of our off duty personnel will probably be slower, as they will make sure their own family is safe before responding to the sta-

In a large scale disaster, the District will be over-taxed and not able to respond to every call. The citizens will be part of the first response, taking care of those in need around them. They should learn First Aid, develop a disaster kit and have a disaster plan.

Our District is developing plans and resources to deal with these disasters. The District has met with Rohnert Park and Cotati and they are being self sufficient, but there is developing an Emergency Operations more to do and we can use some Center that will take care of all of our help. The following items are some fire district. This center will coordinate emergency operations and ordering of resources to assist in our operations.

The District is in the process of installing a diesel fuel tank for our vehicles, and we have installed a container at our Station 1, in Cotati, and a container at Station 2, in Penngrove. The goal of these two containers is to provide limited food, first aid supplies and other necessary supplies for 500 for five days including our own firefighters. These containers contain about 550 gallons of drinking water, some first aid supplies and tools. Our firefighter's association has been using money from its fund raising efforts to stock these

containers with enough supplies to last at least five days. These funds are limited and District has not been able to provide revenue to support these containers as the economic downturn is causing us to use up reserve funds just to maintain services at safe levels over the last two

This goal is lofty but necessary and the District will appreciate any help or donations that they receive. The disaster containers need the following: bags of beans and rice, a turkey deep fryer to cook the beans and rice, canned food, MRE (meals ready to eat), more first aid supplies, toilet paper, propane tanks and even pet food. We need enough supplies to hand out to the citizens in an emergency.

Anyone who wants to donate to these containers can bring donations to the firehouses in Cotati or Penngrove and they will be placed into the containers.

The answer to the question, "Are we prepared for a disaster" can be answered that we are working on suggestions to our citizens:

- 1. Citizens should be prepared to be self sufficient for five days as well.
- 2. Develop a disaster plan
- 3. Make a disaster kit; visit the FEMA web site for more information
- 4. Take some classes, like CPR, First aid, and CERT, some of these classes are available at Rancho Adobe Fire
- 5. Drill with your family-

Cotati can learn a lesson from Novato

.....A story that hits too close to home

Novato is a fine city. It was incorporated in May 1960 and has developed a set of community values that any American city would envy. Years ago, San Francisco had a requirement that its public safety personnel must live within a half hour response time. Novato was at the out reaches of that requirement. That is why so many current and re-

tired San Francisco police and fire fighters live in Novato. They are the backbone of our community. Even before Novato's incorporation as a city, Novato was known as a working man's town. Residents from the other cities in Marin may have said that disparagingly, but in Novato, we have been proud of that distinction.

Our city council and all of our institutions went on as they had through the years. But then something began to change in Novato. Within the past decade or so, Novato became a desirable destination city for hundreds of illegal aliens. At first, this phenomenon did not seem to concern anyone. But conspicuously, about three years ago it became apparent that the community values of which the town had been so proud were being subverted. As a resident of Novato since 1971, I became accustom to our home town just the way it was, and saw it changing for the worse. Like Chicken Little, I wrote letters to the newspaper warning the community that Novato was at the tipping point. The city council did not want to hear it, played stupid, and could not be bothered with enforcing the law. They played every game in the book to avoid the obvious problems associated with this influx of people who were undocumented. The entire Novato City Hall played "hear no evil, see no evil".

This is my town. I helped pay for it legally, and I wanted it to stay that way, a law abiding community. Selfish? Yes. But I moved here after a tour in the Army because I liked Novato and what it stood for. But now, things have changed here. The gang graffiti has become so thick that gangs are painting over each other's graffiti, and the crime keeps rising. But the city council and the police chief turned a cheek and denied that the town was changing for the worse. They tacitly enshrined Novato as a "sanctuary city" for illegal aliens right along side San Rafael. In addition, the city council embarked on a policy of more and more low-income housing at the expense of the California taxpayers. This was in essence tax exempt, high density, welfare recipient type apartment complexes. "Why tax exempt", I asked? "Because we said so", they replied. Who is "we", I exclaimed? "We" turned out to be the Sacramento social engineering legislators who wanted every city in California to be identical with this sort of schlock housing, money that could have gone to the public schools and much more. These liberal legislators had successes such as the City of Antioch, CA., a diverse city with affordable housing where every resident except the hard core criminals is afraid to leave his home or apartment after sundown. That was not going to happen to Novato if I had anything to do or say about it.

So, a small group of Novato and Marin citizens got together and looked to the First Amendment to the United States Constitution, The Bill of Rights, and the California Elections Code. We had a right to engineer our own cities. We drafted a Legal Employment and Contracting Initiative which required local businesses to insist they verify the legal status of a worker before hiring them through the E-Verify system. We thought to ourselves we too can "Think globally, act locally" and rolled up our sleeves.

Through this citizen initiative, we could force employers, local businesses, and city government to hire only legal citizens. We researched the Elections Code and the initiatives which had been successful in other Marin cities and drafted our initiative, collected the required number of signatures, and had the initiative approved for the ballot by the Marin County Elections Officer. Surprise to us, under the Elections Code, the city council could either adopt the initiative by a majority vote of the council and save the cost and expense of an special election, or certify the initiative back to the County Elections Officer for inclusion on the next general election.

However, being a city council that supported the idea of being a sanctuary city, Novato city leaders asked the city attorney to find a way to prevent our initiative from ever being placed on the local ballot. City attorney, Jeffrey Walters researched the request and found that the law of the land was a San Francisco federal case on E-Verify. That decision, Los Chicanos v Napolitano, an Arizona case, said that there was neither implicit nor explicit federal pre-emption that would prevent a state or city from enacting a mandatory E-Verify ordinance. The clever city attorney found a way around our initiative. He quoted the part of the decision which was the losing party's argument and incorporated it into a study that said that the city could refuse to do either, enact or refer to the ballot. So that is what the city did, they took no action on our initiative. After

the council refused to refer the initiative to the county less crime ridden than any other areas elections officer, eleven out of the twelve members of the initiative committee, that I was a part of, tucked their tails between their legs and gave up. I, however, would not be so whipped. I began attending every city council meeting from that moment on, and demanded that the council obey the law and place the initiative on the ballot because we had gained the necessary signatures. After all, the citizens of Novato had a right to vote on it. The mayor, rather, declared on the record and on television, that if the initiative was placed on the ballot, "the voters might vote the wrong way" against Novato being a sanctuary city.. Have you ever heard of anything so arrogant? The mayor essentially said, we know what is good for you, and we are going to force you to live in a sanctuary city whether the people like or not even if we have to break the law and shove it down your throats.



Declaring a city a sanctuary city can be made by decree, or they can be slipped in while no one is looking. Making Novato a sanctuary city essentially invited the illegal alien gangs to "vive, trabaja y vende las drugas aqui"; live, work and sell drugs here in Novato. The FBI did a study that found where there is tolerance for illegal aliens, law enforcement authorities get overwhelmed and begin concentrating their efforts on bigger crimes and ignoring the lesser crimes and traffic enforcement. Novato Police Chief Kreins was asked about this fact in December 2010 and he replied that there were no illegal alien gangs to worry about because there were absolutely no illegal aliens in Novato. He knew this because he had instructed his patrol officers not to ask anyone they arrested whether they were illegal aliens or not, which by the way, violated federal law which requires such an inquiry.

The city council had their trump card, too. They had the power of their public offices to fall back on. They could intimidate at will any member of the public who stood up, objected, protested, and held city leaders accountable for their action and inactions. City leaders engineered a plan whereby they



instructed the police chief to go so far as to arrest me for "disturbing a public meeting", Penal Code section 403, for no good reason one night at a council meeting. They tried to embarrass me, and even threaten my professional licensing as an attorney for turning my back to the city council during my time to speak. The city ultimately charged me with a misdemeanor for speaking out in favor of civil rights, just like people did in marching in Montgomery, Alabama. The police chief wore his blue uniform with his four stars and had his captain put me in handcuffs and hauled me away from the city council meeting one evening for remaining silent during my three minutes to address the council. However, the city council, the city attorney, and the chief of police never bother to check the law. PC 403 was intended to prevent the audience from interfering with a speaker at a public meeting. In this case, I was the speaker who simply turned my back on the city council during my time at the podium. It's on YouTube and shocking. How could I interfere with my own presentation, I asked the council. I spoke for nine seconds during my allotted three minutes of Public Comment and used the rest of the time to remaining silent waiting for an answer to my question. For my obsolesce, I was accused of a criminal act by the city council. Later, the Marin County District Attorney, knowing that he would be made a fool of if he tried to prosecute the case, dropped all charges.

But the overreaching and irresponsible Novato city council would stop there. In fact, they decided they would stop at nothing to silence me. Next, they began surveying Novato for General Plan Update changes to allow more welfare-felon tax exempt housing in town regardless of the fact that Novato, with 30% of the county's population, already had 50% of the county's low income, high density, welfare-felon housing projects. And what successes those low income, high density, welfare-felon housing had been! The property management firms for these housing projects had allowed their properties to deteriorate into the police number one source of calls and complaints. These areas were not crime ridden areas to city leaders because the statistics that the chief of police kept showed that they were

of Novato. This was an outright lie and there are statistics to prove it. Despite the fact that law abiding residents in these complexes were often afraid to leave their units, the city council said that they were successes in government assisted housing.

Then came Novato's New Year's attempted double gang murder at the Safeway store which proved the cat was out of the bag. Now, the police chief had to admit that there was an illegal gang presence in Novato. He also blamed the gang activities on a Caucasian motorcycle gang (to be political correct) and make like he wasn't being a racist. If they accused illegal alien gang members of attempted murderer or worse they felt they had to accuse other people who where white to avoid criticism from the left in town the council was picking on one single racial group. Fact is, no one has seen any motorcycle gangs in Novato since the 1980s when the town motorcycle Club closed down.

But since the autocracy of the city council and their seeming unassailability had been challenged, another issue came to the fore, "affordable housing". The Sacramento leftists wanted every California city to be identical, after all that is what equality is all about isn't it? No. The law of the land speaks to equal opportunity for all, not equal results for all. "Affordable housing" seeks to have Novato taxpayers investing their Novato tax dollars into welfare housing so that those who earn little or nothing can live as sumptuously as those who work their collectives asses off. Novato already has 50% of Marin's welfare housing even though it is a community with only 30% of Marin's population. Why ABAG, Associated Bay Area Governments chose Novato for the majority of Marin's affordable housing goals, who knows? It may be because Novato is such a desirable place to live. It may be because the city council has always done what it was told to do and scared to stand up for itself.

But Novato citizens rose up against this social engineering gone wrong. Whereas Gail Meyers had scolded the council of its transgression to an audience of 10 or 15 people, now 200 to 300 Novato citizens attended council meetings, and spoke their minds and it got heated.

The "affordable housing" opponents stopped the council in its tracks. The city council had to engineer an appearance of acknowledging the public will. So, city leaders and staff had meetings, and meetings, and more meetings. In the end, these meetings did dissuade the council from the most egregious actions, but the council still got its way, more affordable housing. If the council had really listened to its citizens, it would have sued ABAG and challenged SB 375 as unconstitutional. That would have truly reflected the will of the people.

Currently, there are two lawsuits pending against the City of Novato and the city council. The lawsu to compel the initiative to require E-Verify for city jobs to be placed on the next ballot was rejected by "activist" Judge Lynn Duryee. An "activist" judge is one who rules in accordance with political correctness, now the law. That lawsuit is on appeal to the Appeals Court in San Francisco. In light of the U.S. Supreme Court decision that there is no federal preemption, that appeal has a possibility of surviving even SF leftism. The other lawsuit against the council is for violating my civil rights, for suppressing my free speech rights, and for the false arrest during a council meeting. The outcome in that matter may be years down the road.







My wife and I usually see one Giants home game a year. Months ago, we decided the September 11 game against the Dodgers would be the most appropriate for many reasons, the pregame ceremony being the largest.

Not because the games were important in and of themselves, but because interrupting our favorite rituals would show terrorists everywhere that our fighting spirit could be shaken. Despite this, in the months immediately following, I was encouraged by the way Americans of all political convictions were united by a jihadist attack on our core values. 


September 11, 2001

Ten years later, we have slid into a pre-9/11 malaise, and some of our finest moments of unity have devolved into a swamp of endless partisan bickering. So I didn't know quite what to expect at a game in the heart of progressive country.

Fortunately, on Sunday, I was surprised on every level. Twenty-five minutes before the game, the sound of bagpipes and drums filled the park, a sad but comforting sound that has defined countless FD and PD funerals. The Stewart Tartan Pipes and Drums of San Francisco entered from right field, followed by San Francisco firefighters, police officers, members of the San Francisco Sheriff's Department, and representatives of the pilots' and flight attendants' associations.

The entire crowd stood respectfully, and in a very short time, most of the players lining the baselines realized it was appropriate to remove their caps. Everyone in the audience had been given a card with a flag on one side, and the name of a 9/11 victim on the other. Sadly, there were 2,977 different cards. As the pipes played, the crowd held their flags high. On the field, a large American flag was unfurled.

Sunday afternoon, nobody threw the ceremonial first pitch. Instead, Bruce Bochy placed a ball on the mound in honor of everyone who died in the attacks. A moment of silence was observed.

Most tellingly, the starting pitchers for both teams continued to throw warmup pitches during the entire ceremony. Nothing could have been more appropriate. No matter how much we grieve, or how much we want revenge, baseball goes on. Life goes on. And something fundamentally good about America, despite considerably long odds, goes on.

Are there jihadis out there who wish they had bombed civilians all across the country? Of course. Were they able to? No. In the first inning, I saw a cane come flying — not dropping — from the upper deck, where it laded out of sight on the deck below us.

That, oddly, may have been the best thing about the whole afternoon, better than the 8-1 Giants win, and even better than the pre-game ceremony. It is wonderful to know that despite the intentions of fanatics who have killed thousands of us, and would love to kill millions, that the worst thing that happened on the Tenth Anniversary of 9/11 was some poor Giants fan getting bonked by a flying cane.

With 8 different Eggs Benedict served daily, not just for Sunday anymore, this kitchen sings to me with homemade Hollandaise sauce (who does that at a diner?) and eggs that are poached to perfection. For my non-egg loving husband, a side of country potatoes and sausage patties. 3 good sized and very tasty did it for him. The wait staff is friendly and efficient. Plates fly out of the kitchen and arrive HOT at the table. Who can ask for more? But wait, there is more. KC's has specials during the week for dinner. Wednesday night "Ribeye" served with choice of potato, veg and bread \$14.95 from 4pm till they run out! Friday & Saturday, slow roasted "Prime Rib" served with choice of potato, fresh veg and bread \$16.75 - \$22.95 (depends on the size you pick) 4:30pm till they run out. Hurry. The new location in Cotati, next door to the Tradewinds bar, would be a welcome addition for pizza since Giovanni's down the street has been closed since July with no sign of reopening. But after two mediocre pizzas from Brixx sampled while at the Tradewinds (the bar and restaurant share a pass-through window for food service) I was underwhelmed and felt over-charged for pizza that had too many conflicting flavors. Less is definitely more, and unfortunately Brixx thinks more is more.

Perhaps I am not the only food critic around these parts. as the once open for lunch sign is now dark, it's dinner only. Our dinner visit at the restaurant was even less of an enjoyable experience as the food came out way too slow. The server was fine, but the kitchen needs help in organizing their time. With a room less than half full (capacity is maybe 30 people) why did it take 25 minutes to get a starter salad? I asked for their signature pizza, "4th Rock from the Sun" sausage, roasted red peppers, purple onion, mozzarella & goat cheese. It looked like a snowy white out on a plate. Way too much cheese and I almost needed a magnifying glass to see the sausage. I think the mozzarella and the goat cheese were in conflict with each other as the taste came across sour. Alias, the thin crust was wonderful so I ended up scrapping off the toppings and ate the crust.

The other dish ordered was a "Monsieur sr." hickory smoked ham sandwich with roasted red peppers, gruyere & pesto. Not very good. Bread was stale and under toasted, and the Caesar side salad was way over-dressed which wilted the lettuce making it inedible. I am hoping the charming owner of this restaurant takes a cue and attempts to re-work his menu of pizzas and gets back to basics.

Lagunitas' motto is "Beer Speaks, People Mumble". Does that say it all? With beer names like Hop Stupid, Little Sumpin Sumpin, Gnarly Wine and Censored, this place does almost everything right. A true beer garden with great outdoor patio and indoor seating, live music and now they are building a small amphitheater on the green, next to the "Schwag Shop" for those who need to buy T-shirts and such to identify themselves as true believers that beer is better than wine!

For me, I prefer only the original brew, Lagunitas IPA. A true ale with a wonderfully nutty flavor and golden color. For the more adventurous, the pub offers many combinations of beer tasting specials, any 4 for \$5 served in 4 oz glasses. Or, you can take home a 1/2 gallon "Growler" of any Lagunitas beer. The menu sticks to panini sandwiches, dips and chips, one salad, a simple cheese and fruit plate, and newly added special sausage sandwiches and chili.

Recently, I made a suggestion that the menu ought to include hand-made potato chips with a couple of dipping sauces as the Spring mix salad with vinaigrette is getting boring. They don't want to intrude on nearby restaurants serving french fries, so potato chips are a good bet. Warning: the chili is not so good and the sausage sandwich isn't much better. But the paninis and the Hummus and Pita Chips rock. The chips are very thin and crunchy. Last week they had a guy BBQ'g fresh oysters, yummy. All told, this is a find and a half. Best visited while the sun is still shining.

This restaurant continues to please the palate and the pocketbook. Well prepared food at reasonable prices. The new location (original was in the old, Golden Eagle Shopping Center, next to the now defunct Rosens Restaurant) has a very warm atmosphere and the staff is welcoming and efficient.
